Agenda Item	Details
<b>Active Living Objectives</b>	The subcommittee agreed with and accepted the written objectives of the Active Living Subcommittee. Future changes can be made to objectives.
<b>Outcomes and Expectations</b>	Subcommittee discussed what expectations and outcomes are wanted, which included; Highlighting active living work by partners creating community of learning, sharing success stories among partners, finding better ways to implement programs and ways to involve more community members in physical activity.
<b>Matrix &amp; Work Plans</b>	Subcommittee members agreed that a working “matrix” would be beneficial to know what each county is doing for AL strategies 6, 7, 8, 9. Theresa and Anissa will get together to develop a new “working matrix” for each county to insert projects. Also, 3 contractors were solicited to discuss what they are working on. Kay volunteered to provide updates on evaluation for AL strategies and 2 more contractors will be finalized before the next meeting.
<b>Valley Metro Be Bright Partnership</b>	AzNN and Valley Metro have been working together to provide an opportunity for partners to get training in Safe Routes to School and a comprehensive Walking School Bus program. The Be Bright program has offered resources from their program which includes event materials and program curriculum/resources. The training would likely take place around January-February 2016. The intent of the training would be to get partners ready for program implementation for the 2016-2017 school years. Most partners were interested in

	attending this training and learning more about the Be Bright program to gain resources and education.
